

NFL JERSEY GIVEAWAY

TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter this Competition forms part of the Terms and Conditions of entry. Participation in this Competition is deemed acceptance of these Terms and Conditions of entry.
2. This Competition is being run by Doxa Community Club Inc (**ABN 11 129 790 47**) (**DCC**).
3. The Competition will open at 10am on 31 August 2026 and close at 1pm on 10 September 2026 (**Competition Period**).
4. Participation Eligibility and Exclusions:
 - a. Entry is open to all Victorian residents aged eighteen (18) years and over;
 - b. Exclusion of Related Persons: Individuals categorised as related persons, encompassing directors, officers, employees, agents, servants, contractors, advisors, or owners are expressly prohibited from participating in this draw;
 - c. Consequences of Unintended Participation: In the event that a related person inadvertently takes part in the draw without the knowledge of DCC and their name is subsequently selected, they shall immediately forfeit any entitlement to a prize; and
 - d. Entry is not open to self-excluded or barred persons from one or both of the following DCC venues:

Competition draw will take place on 1pm 11 September 2026 at DCC Head Office, Level 2, 315 Elizabeth Street, whereby a Participant will be selected at random by DCC Management and declared the winner of the Competition. They will be contacted via direct message on Instagram, as well as announced on @clocksatflinders Instagram Stories. Participants are not required to be present at the draw to claim the prize.
8. The prize is one (1) x Official NFL Jersey valued at \$200.
9. If a winner does not claim the prize within forty-eight (48) hours of notification, the prize will be redrawn until a winner is found. The re-draw winner will also be given forty-eight (48) hours to come forward and this process will continue until a winner is found.
10. The prize must be paid to the winner within twenty-eight (28) days of the draw taking place.
11. Management reserves the right to require proof of identity when claiming the prize, as well as the right to disqualify any person who fails to provide the required information or who provides false information.
