



MEMBERS DRAGON DRAW

TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter this Competition forms part of the terms and conditions of entry. Participation in this Competition is deemed acceptance of these terms and conditions of entry.
2. This competition is being run by Doxa Community Club Inc (**DCC**) at:
 - a. Clocks - Shop 17, The Concourse, Flinders Street Station, Melbourne, VIC 3000; and
 - b. Central Point - 315 Elizabeth Street, Melbourne 3000.
3. Competition draw will take place on the last Thursday of every month from 5:30pm until 7:30pm, unless otherwise altered or cancelled by DCC management. In such cases, notice will be given to Members.
4. Participation Eligibility and Exclusions:
 - a. **Automatic Entry:** All existing active members of Doxa Rewards shall be entered into the Competition by default. Members who have been barred shall be ineligible.
 - b. **Exclusion of Related Persons:** Individuals categorised as related persons, encompassing directors, officers, employees, agents, servants, contractors, advisors, or owners are expressly prohibited from participating in this draw.
 - c. **Consequences of Unintended Participation:** In the event that a related person inadvertently takes part in the draw without the knowledge of DCC and their name is subsequently selected, they shall immediately forfeit any entitlement to a prize.
 - d. **Membership Requirement:** Members are required to maintain their active membership status to be eligible for prize claims.
 - e. **Lapsed Membership Redraw:** In the circumstance that a membership is found to be not up to date, a redraw of the competition will be executed
5. Members must be at either Clocks at Flinders Street Station or Central Point Melbourne at the time of the draw to claim the prize. They will be required to present themselves to DCC Management within four (4) minutes of their Name and Membership Badge Number being called.
6. The computer (via Ebet Membership Program & Outabox draw function) will select a Member's Name and Membership Badge Number at random.
7. The prize draw is \$5000 and will commence at 5.30pm on the specified date.
8. Once a Member's Name and Membership Badge Number has been drawn, the Member will



- have four (4) minutes to claim the prize. If the Member is not present to claim the prize and does not let themselves known to Management within the 4-minute time frame, it will be re-drawn.
9. Re-draws will take place in ten (10) minute intervals until a winner is found. The re-draws will stop once a winner is present and has made themselves known to Management.
 10. If no Member has claimed the prize by 7:30pm, Members' Names and Membership Badge Numbers will then be drawn from ONLY the pool of Members who have swiped their Membership cards at the bar tills or Gaming Machines between 5:30pm and 7:30pm.
 11. Consecutive draws from this pool of Members who have swiped their Membership cards will take place every (4) minutes until an eligible Member is found.
 12. Management reserves the right to require proof of identity and Membership card, as well as the right to disqualify any person who fails to provide the required information or who provides false information.
 13. The winner will be given the option of winnings in the form of a cheque or cash plus cheque. This cheque will be made out in the winner's full name; as shown on their Membership card.
 14. Prize winners are advised that tax implications may arise as a result of accepting their prize. DCC is not responsible for such tax implications and prize winners should seek independent financial advice where necessary.
 15. By accepting their prize, each prize winner acknowledges and consents to participating in promotional activities relating to the prize. These may include; promotional photograph shoots and media interviews. DCC may use all photographs and recorded interviews (including the prize winner's image, voice, name and other details), without restriction and without further reward or recourse to the prize winner.
